Applications meeting eligibility criteria will be reviewed by Emeritus, followed by an interview. Admission will be offered to selected candidates.

Documents Required

The required documents include 10th and 12th marksheets, a copy of degree/diploma, a copy of degree/diploma marksheets, a valid ID proof, resume, work experience letter, and optionally a letter of recommendation.

Language Requirement

Level of English equivalent to TOEFL IBT (internet-based test: 80) or TOEFL PBT (paper-based test: 550) or TOEIC (780) or IELTS: 6.0 or Cambridge (FCE). No language test will be required if the student can prove that he has studied and obtained a degree fully taught in English, or if the student is a native English speaker.
